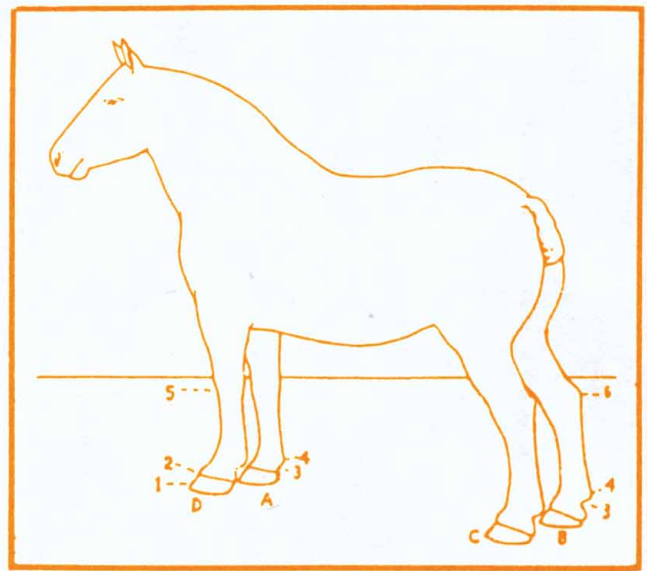
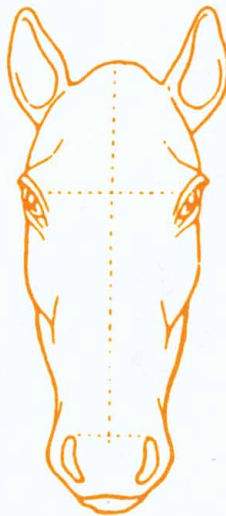
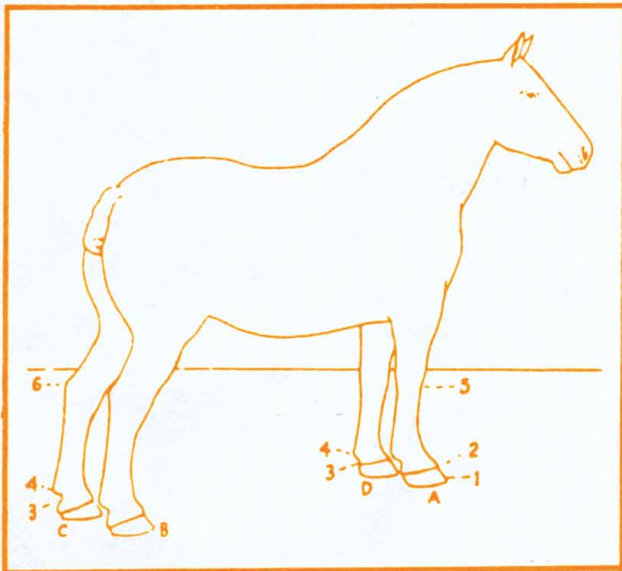

The Registry will refuse to register any animal if such registration is deemed detrimental to the object of the Registry as stated in its By-Laws.
