- Applications are due May 31st.
- Payment schedule is as follows:

 - 20% late fee will be applied after August 1, 2024.
 - Payment in full is required by September 1, 2024
- L & P Designs is the exclusive vendor for NABC Apparel. No other apparel vendors will be permitted to sell any NABC branded wear.
- Shipshewana Harness is the exclusive tack vendor for the NABC. All other tack and equipment vendors will be permitted at the discretion of the committee.
- Vendors are expected to arrive no later than Monday, September 23rd at 12:00 pm CST. Vendors are expected to stay the duration of the show. No tear down will be permitted prior to the conclusion of the show.
- Vendors are expected to have their booths open from 8:00 am to 5:00 pm CST.
- The NABC X is having a celebration dinner on Saturday night. Tickets are \$10 a piece and must be purchased prior to Monday September 23rd. You can order tickets on the Tradeshow Exhibitor contract or by contacting Michelle Keaffaber.
